



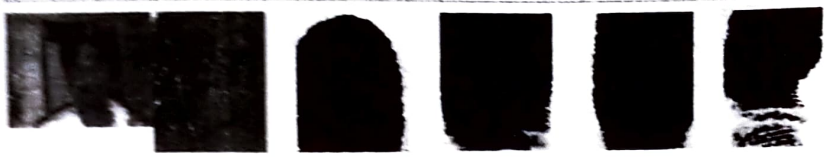

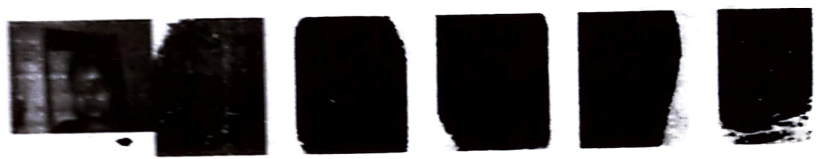

(1) That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, a sum of Rs.51,000 (Fifty one Thousand) hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever into which the same of any part there of might be converted ; invested or varied from time to time of which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

(2) That the name of the trust shall be **DEORANI DEVI MEMORIAL TRUST (DDMT)** and office will be situated at Arya Samaj Mandir Road, R.P.S. More, Bailey

(3) That the object for which the trust is established shall not involve for carrying on any activity in the nature of trade , commerce or business , or any activity of rendering any service in relation to any trade commerce or business, for a cess or fees or any other consideration are following :

(a) To impart the education and all incidental activities including but not limited to Schools, academies , coaching classes , colleges, for imparting education to students in the field of science ,commerce ,arts ,engineering , management computers, both in India and outside India .

(b) To conduct Vocational Education Guidance, Training and skill Development Programmes, Conversion of traditional Indian languages in multinational languages and according Software Development Computer Programming, Communication, IT, Electronic and printing technologies, development and utilities, Vocational education, research training and development programmes and award certificates.

(c) The trust is being organized for the promotion of spiritual, physical, mental, educational development and upliftment of adults and children of all ages without any distinction of caste, creed religion and in the interest of mankind in general.

(d) To aid or establish take over or collaborate with any institution or school or association, for physical, mental, educational development, uplift of intelligence or its development.

(e) To aid or establish any institution or adopt means for imparting promotion of any art, science of any other field of education, propagate for removal of social evils, customs or tender or promote self-help to overcome. Any of these evils particularly for the poor or the weaker section of the society in India or elsewhere.

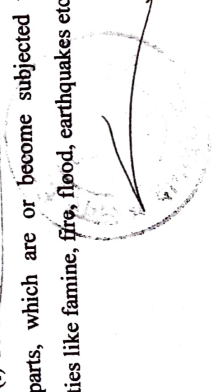

(i) Publication propagation and dissemination of the Educational Work through audio-visual and print media.

(l) To start, maintain and assist in relief measures in those parts, which are or become subjected to natural calamities like famine, fire, flood, earthquakes etc.

(m) To carry on programme of small & Rural Technologies Promotion and Development, Food and nutrition Disaster Management, Human rights, Customer education & protection, Computer and Information Technologies Research and Management, Added- Value Programmes.

(n) To carry on project of Development, Employment creation and opportunities Development, Leadership development, legal aid & protection, Antipoverty, Refugees, Public Health Micro Enterprises Development, Techno-Entrepreneurship development, Slum community development, Social Welfare, Street children, Labour Children, Prisoner's education.

(o) To award prizes, medals and like in universities, colleges schools etc. to encourage students for higher and better education.

(p) To given stipends allowances or gratuities, recurring or otherwise, for the maintenance etc. for such time or duration as any deem proper and necessary.

(q) To render help, arrange for and encourage and promote celebrations of national, cultural, social and such other festivals and jayanties as conductive to this object. (r) To promote, establish, support, maintain or grant aid to institutions, in India, leaving similar objects for the benefit of the public in general.

(p) To establish, promote, manage, organize maintain or to aside in establishing, promoting, organizing, or maintaining any branch or the Trust or any other Trust or its branch with objects similar to those of this trust and to promote or carry on the affiliations or amalgamation of such other Trust with this trust.

(r) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.

(s) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

(t) To transfer and hand over the Trust to any other Society, Corporations, Institution, Trust or organization with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall stand discharged from the Trust hereof relating to trust Funds so transferred.

(u) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.

(8) The Trustees shall be accountable only for such moneys, and funds, which will actually come into their hands.

(9) The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

(10) The managing Trustee for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointments the trustees for the time being consider proper.

**11. A person shall cease to be a trustee either:**

- If he/she without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or
- If he/she is requested to resign by 3/4<sup>th</sup> or as near thereto as possible of the remaining trustees.

12. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.

13. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:

(a) Two Trustees shall form a quorum for a meeting of the Trustees.

(c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

14. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.

15. The accounting year of the Trust shall be the financial year ending on 31<sup>st</sup> March every year.

16. The Trust and the Trust funds shall be irrevocable for all the times.

17. It is expressly declared that no part of the Trust proper or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.




